classes at Harvard while heading out on assignment on the ship, the U.S. Army Transport Dorchester, which later sunk in a great tragedy while crossing the North Atlantic on February 3, 1943.

The Dorchester was transporting troops over to an American base in Greenland when a German U-Boat fired a missile at the ship, which killed 672 of the 902 officers and enlisted men, merchant seamen, and civilian workers onboard.

These four chaplains, through their courage and leadership, despite their different faiths and backgrounds, helped to save many, and created after them "a unique legacy of brotherhood".

The four chaplains comforted the wounded while soldiers rushed to the lifeboats, and one survivor recalled seeing them handing out lifejackets, ensuring others' safety before their own, even giving their own to someone else.

As the Dorchester sank, the chaplains were seen linked arm in arm, praying.

The ceremony at the library documented the lives and legacy of these men, and served as an opportunity to remember them on the anniversary month in which the USAT Dorchester sank.

"We also commemorated the 250th Anniversary of the Chaplain Corps," said Willette.




Brian Willette, the South Hadley American Legion Post 260 Commander, greeting the people who came for the Four Chaplains ceremony.

"The Chaplain Corps was established on July 29, 1775, and 218 chaplains served in the Continental Army during the Revolutionary War. Army chaplains have participated in every major conflict involving the United States since. The Chaplain Corps has eight recipients of the Medal of Honor," Willette said.

At the Arlington National Cemetery, there is a Chaplains Hill, which commemorates the military chaplains from four wars, and is their final resting place.

Those buried here include the Army's first chief of chaplains, Col. John T. Axton, a veteran of World War I; World War II's chief of chaplains, Maj. Gen. William R. Arnold, who was the first chaplain to become a general; and Maj.

Charles Joseph Watters, who served in Vietnam and posthumously received the Medal of Honor for his selfless actions on November 19, 1967.

"They inspire me in the fact that they came together without planning it naturally stood together to accomplish the same goal, to help as many of those soldiers as possible, to even give their own lives, seemingly without hesitation," Willette said. "Their diverse backgrounds immediately become unimportant, but their common goal of saving lives and performing their spiritual mission came to the forefront."

The South Hadley Pack 303 Sea Scours were a part of the ceremony and was their first exposure to the story of the Four Chaplains, and Willette's and other members of

the South Hadley Legion's working with the group.

"Some day they will take the lead on this. This is a story for our youth to know and to pass on for future generations, and here in South Hadley it will be the Sea Scouts who will ultimately carry this story on," said Willette. "We look forward to many more years though of teaming up with them on keeping the Four Chaplains story alive."

Father John Smegal, an Army Chaplain, was also present at the ceremony, and gave a speech about the Four Chaplains, and what they

meant to him.

"Father Smegal embodies the spirit of the Four Chaplains himself. Father retired as a priest in the Diocese of Springfield and in retirement asked what now he could do for his country. How could he continue to serve God and man. His answer was to join the Massachusetts Military Defense Forces to serve his soldiers spiritually for the good of our nation," said Willette.

The plan to bring this ceremony into the public eye was one that was long in the making, and it is truly a joy to

"But it is just a start," said Willette, stating that this ceremony is planned to be held annually on Four Chaplains Day.

The story of the Four Chaplains is truly one of true bravery, love, and selfless sacrifice, as these four men, though of differing beliefs, gave their lives for those in their care
